THE MORTUARY PASSPORT FOR THE TRANSPORTATIONS ABROAD OF BODIES OR ASHES, MAY BE ISSUED ONLY AFTER A REQUEST IN STAMP MADE BY THE RELATIVES OR BY THE ENCHARGED FUNERAL COMPANY; IT IS NECESSARY TO ATTACH THE FOLLOWING DOCUMENTS, SELECTED ACCORDING TO THE VARIOUS CASES:

### 1-TRANSPORTATIONS OF THE BODIES TOWARDS A FOREIGN COUNTRY:

A) MEDICAL CERTIFICATE ATTESTING THAT THE DEATH WAS NOT CAUSED BY WIDESPREAD-INFECTIOUS DISEASE.

B) ASL REPORT ATTESTING THE RIGHT CLOSURE AND SEAL OF THE COFFIN;

C) ASL CERTIFICATE ATTESTING THAT THE BODY HAS BEEN TREATED WITH **ANTIPUTREFACTION PROCESSING**;

D) NULLA OSTA (AUTHORIZATION) OF THE FOREIGN DIPLOMATIC AUTHORITY IN ITALY (**EMBASSY OR CONSULATE**) OF THE COUNTRY WHERE THE BODY HAS TO BE BROUGHT; EXCEPTION IS MADE FOR THE COUNTRIES THAT ADHERE TO THE CONVENTION OF BERLINO (AUSTRIA,BELGIUM, CHILE, CZECH REPUBLIC, DEMOCRATIC REPUBLIC OF CONGO, DENMARK, EGYPT, FRANCE, GERMANY, HOLLAND, MEXICO, PORTUGAL, ROMANIA, SLOVAKIA, SWITZERLAND, TURKEY)

E) NULLA OSTA (AUTHORIZATION) OF THE PROCURA DELLA REPUBBLICA IN CASE OF NON-NATURAL DEATH (VIOLENT DEATH);

### 2) TRANSPORTATION OF ASHES TOWARDS A FOREIGN COUNTRY:

THE MAYOR ISSUE THE AUTHORIZATION FOR TRANSPORTATION IN WHICH THERE ARE THE INDICATIONS OF THE FULL PARTICULARS OF THE DECEASED, DEATH DATE, EXHUMATION OR CREMATION DATE AND THE DESTINATION COUNTRY.

THE TRANSPORTATION OF THE CINERARY URN ARE NOT SUBJECTED, IN ITALY, TO THE HYGIENICAL INSTRUCTIONS FIXED FOR THE BODY TRANSPORTATION: THIS INDICATION IS VALID BOTH FOR THE STATES THAT ADHERE TO THE CONVENTION OF BERLINO, AND FOR OTHER STATES. ANYHOW IT IS NECESSARY TO OBTAIN THE NULLA OSTA (AUTHORIZATION) ACCORDING TO DECREE OF THE PRESIDENTE DELLA REPUBBLICA N.285 10/09/1990 ART. 29,SUB.1 LETTER A).

### COSTS

ONE STAMP FOR THE REQUEST AND ONE STAMP FOR THE MORTUARY PASSPORT ISSUE.

### RELEASE SCHEDULE

AFTER THE SUBMISSION OF THE FULL DOCUMENTATION, THE REGISTRAR ISSUES THE MORTUARY PASSPORT.

**WARNING**

THE SIGNATURE OF THE ISSUING REGISTRAR MUST BE LEGALIZED BY THE PREFETTURA.
